## Application Area

GREVEN® ACTIVE PEARLS® is suitable for the removal of medium to heavy dirt, e.g. from grease, oil, metallic dust, graphite or soot, especially when hands are washed frequently.

## Product Description

GREVEN® ACTIVE PEARLS® is a hand cleanser for medium to heavy dirt with excellent cleansing power, which does not affect the skin by sharp-edged, abrasive scrubbing agents. Due to the patented dirt-removing agents Active Soft Pearls® (ASP), the product GREVEN® ACTIVE PEARLS® has a strong cleansing effect but at the same time, it is gentle to the skin.

## Product Properties

- The innovative Active Soft Pearls® (ASP) do not support the cleansing effect of the surfactant combination by mechanical abrasion, as conventional scrubbing agents would do, but by their polar surface structure which is able to bind greasy dirt particles.
- The soft and smooth pearls made of hydrogenated castor oil (wax) can remove dirt particles without affecting the skin. Rather: waxes are preferentially used in skin-care products because of their gently caring and smoothing effect.
- The ASP are used in combination with a mild, but effective surfactant combination on the basis of acyl glutamate as well as lipid-balancing glycerol esters.

AQUA, HYDROGENATED CASTOR OIL, COCO-GLUCOSIDE, GLYCERIN, SODIUM COCO-SULFATE, BRASSICA CAMPESTRIS SEED OIL, OLEIC ACID, SODIUM CHLORIDE, MAGNESIUM STEARATE, GLYCERYL OLEATE, SODIUM BENZOATE, POTASSIUM SORBATE, XANTHAN GUM, CITRIC ACID, PARFUM.

## Application

Apply GREVEN® ACTIVE PEARLS® evenly on the dry skin. Continue washing adding little water. Rinse off with plenty of water and dry hands thoroughly. If the product gets into the eyes, rinse thoroughly with plenty of water.

## Certificate of Dermatological Compatibility

The dermatological compatibility of GREVEN® ACTIVE PEARLS® has been carefully tested and proven. A printed certificate is available.

## Ecology

The surfactants used fulfill the requirements of easy biological degradability as they are determined in the Regulation (EC) No 648/2004 on detergents. The laboratory testing of surfactants in the context of this regulation is based on the "Confirmatory Test" procedure of the OECD method.

## Statutory Regulations

GREVEN® ACTIVE PEARLS® is subject to the Regulation (EC) No 1223/2009 on cosmetic products. Further details on handling the product can be obtained from the Group Data Sheets for skin products (for occupational use).

## Storage Instructions

The product will keep for at least 30 months (from date of manufacture) if stored unopened at room temperature in the original packaging. The Period After Opening (PAO) is indicated on each tube / bottle.
